"Instructs heavy equipment operator course in accordance with approved Program of Instruction (POI). Provides oral and written feedback to students. Administers verbal and written exams in accordance with approved POI. Creates, prepares, and delivers daily lesson plans. Assists Training Coordinators with the procurement, movement, staging, and maintenance of required course equipment. Assists the Training Coordinators through providing input to short and long term initiatives in support of the Jobs and Hope training program. Liaisons with military and civilian educational entities is support of course operations. Supervises engineer projects; interprets information on grade stakes; critical path methods; oversees clearing, grubbing, stripping, excavating, backfilling, stockpiling, hauling, construction of ditches and other heavy equipment operations; performs route reconnaissance; responsible for the health, welfare and safety of students. Ensures students meet standards in personal appearance; supervises students on maintenance, classes and operating heavy equipment; such as bulldozers, road grader, scrapers, dump trucks, compactors and Hyex's. Transport heavy construction equipment. Construct embankments, Excavate hills and slopes with crawler tractor, finish slopes, mix soil stabilization materials, construct embankments, perform surface and drainage maintenance.
